You are invited to join / re-join Mendip Beekeepers Association for 2024.

For 2024, Mendip BKA subscription remains at £6.50, BBKA subscription remains at £21.00, and the Bee Disease Insurance (BDI) remains at 2023 rates.

Somerset BKA subscription has increased to £15.00. This increase is to build funds, to ensure adequate provision of equipment and resources to support the County's response to the increasing threat from the Asian Hornet.

Associate members must reside at the same address as the full member with whom they are associated. They do not receive the monthly BBKA newsletter.

Voluntary Bee Research

The Voluntary Bee Research fee is optional and is collected by Somerset BKA. This year, donations will continue supporting the European Foul Brood (EFB) PhD programme, researching the particular strain we have in Somerset.

Insurance

Membership of BBKA includes insurance cover for activities arising from members' beekeeping activities and the provision of beekeeping products. Information is available on the BBKA website members' area. Bee Disease Insurance is supplied by BDI Limited and is not included in the BBKA subscription. Bee Disease Insurance Ltd. (BDI) is an insurance company set up and run for beekeepers by beekeepers. It promotes research, education and disease control methods for honey bee disease. It also compensates subscribing beekeepers and their bee colonies in England and Wales in respect of losses caused by statutorily notifiable honeybee diseases and pests. Currently these are American Foul Brood, European Foul Brood, Small Hive Beetle and Tropilaelaps Mites. Information is available online at BeeBase.

If payment for insurance is not received by the end of March 2024 your insurance ceases. Late payment then causes a 40 day delay before your insurance is activated.

The chain of administrators from Mendip, through Somerset and the BBKA would welcome prompt payment!

N.B. Make sure you are correctly insured. If, in the event of a claim, you are found to be under insured and have more hives than specified by your subscription, the complete cover is invalid. Also if you share an apiary with other beekeepers make sure they are all insured as an uninsured beekeeper in an apiary invalidates your insurance.

Taxpayers

If you are a UK taxpayer, please sign the Gift Aid Declaration, as this increases the value of your subscription. We are unable to claim Gift Aid if your tax status is not declared.

Data Privacy

In order to comply with the current Data Protection Regulations, there is a form attached that also needs to be completed as part of your membership renewal.

Please could this form also be completed by any Associate Members living at the same address.

Swarm Collector Request

Please could you indicate on the renewal form if you would like to be registered as a Swarm Collector.

Please be advised that your postcode and contact details will be visible on the BBKA and SBKA websites if you select this option.

Honey Sales

Please could you indicate on the renewal form if you would like to be registered as a Honey Seller.

Please be advised that your postcode and contact details will be visible on the BBKA and SBKA websites if you select this option, so potential customers can contact you directly.

Beekeeping Courses and Qualifications

Please could you indicate any beekeeping courses and / or qualifications you may hold. This will ensure that the Somerset Yearbook and Mendip BKA records are kept upto date.

Beebase Sharing of Data

Please could you indicate if you are willing to share your details with Beebase.

Until now there has been no automatic sharing of data from local associations to BeeBase through the eR2 membership database. This link will enable consenting member's details to be shared with the National Bee Unit (NBU).

BeeBase is a valuable beekeeping resource maintained by the NBU. In addition to providing information to beekeepers, it maintains a voluntary register of Beekeepers.

This register enables the Regional and Seasonal Bee Inspectors to know where Beekeepers and their apiaries are located and allows them to make contact in the case of a disease outbreak, with a view, if necessary, to undertaking a disease inspection. The Inspectors are experienced Beekeepers and their visits often provide valuable training for the individual Beekeeper.

Should a Beekeeper have an outbreak of a notifiable disease, and have cover provided by BDI, the Inspector will validate the insurance claim on their visit.

Please indicate the postcode of your apiary, if it isn't at your home address.

Asian Hornet Action Team (AHAT)

There has been an increasing prevalence of Asian Hornet confirmed sightings during 2023. Each Division needs an Asian Hornet Action Team (AHAT), which forms part of the Somerset AHAT.

If you haven't done so already, please consider volunteering. The main task would be to help identify and locate any sightings reported locally. Please consider volunteering for this. It does not require any direct contact with Asian Hornets. It is the responsibility of the Bee Inspectors to destroy any confirmed colonies that are located.
